## GRIP EXTREME

Is a water based rapid drying adhesion promoting primer for interior and exterior use. It will isolate stains such as nicotine, graffiti and water and is also ideal for use over difficult substrates including glass, ceramic tiles, melamine and previously painted surfaces, as well as most wood and non-ferrous metals.

Limitations	Do not apply when air or substrate temperatures are likely to fall below 8°C or when the relative humidity is above 80% during application or the drying period. When used as a stain block primer two coats are recommended. NOTE: When used as a stain block primer two coats are recommended. A trial test area is recommended over severely stained or suspect surfaces. For extremely chalky, powdery, charred or unstable surfaces a <b>Crown Trade stabilising solution</b> should be used.
PREPARATION	
New Surfaces	All surfaces must be sound, clean, suitably dry and free from anything that will interfere with the adhesion of the materials to be applied. On uncoated porous wall and ceiling surfaces, the first coat can be thinned with up to 10% clean water.
Previously Decorated Surfaces	All surfaces must be sound, clean, suitably dry and free from anything that will interfere with the adhesion of the materials to be applied e.g. dirt, grease etc. Remove all loose, failing or suspect paint. Feather edges of sound paint. Remove all dust. Organic growth must be treated with <b>Sandtex Trade Fungicidal Solution</b> and removed. Fill any fixing holes, cracks and shallow surface defects with <b>Sandtex Ready Mixed Filler</b> . Patch prime bare and filled areas with <b>Crown Trade Grip Extreme</b> Wash remaining sound paint or any smoke, graffiti or soiled areas (excluding water stains) with hot water and liquid detergent solution to remove any contaminants, frequently changing the water. Any glossy or eggshell surfaces should be wet abraded to provide a key. Rinse with clean water to remove all residues. Allow to dry.

<b>COATING SYSTEM</b>	Apply one coat, two coats over stains - see limitations. Note: If Grip Extreme is to be overcoated with a water-based finishing system on wood or non-ferrous metal substrates, a water-based primer undercoat must also be used.
<b>APPLICATION</b>	Stir well before and during use. Apply using good quality tools – synthetic brush or short/medium pile roller. For airless spray dilution may be required. For further information follow the spray manufacturer's guidelines. NOTE: When used as a stain block primer two coats are recommended. A trial test area is recommended over severely stained or suspect surfaces. For extremely chalky, powdery, charred or unstable surfaces a <b>Crown Trade stabilising solution</b> should be used.
<b>CLEANING</b>	Return surplus material to container. Wash tools & equipment with clean water or a warm soapy solution immediately after use.
<b>STORAGE</b>	Store upright and secure. Store in secure dry conditions inaccessible to children or animals. Containers should be kept closed during storage. Do not store below 5°C or above 40°C.
<b>HEALTH AND SAFETY</b>	Please refer to the Safety, Health and Environmental Information on the container. Take special precautions during the surface preparation of pre 1960's painted surfaces as they may contain harmful lead. For further information contact the Crown Trade Customer Relations Team. When preparing all surfaces avoid the inhalation of dust and/or metal particles. Wear a suitable facemask. Material Safety Data Sheets for this and all other Crown Paints products are freely available from the place of purchase or the address below. Do not empty into drains, watercourses or access routes to septic tanks.
