### 5.3 Advice for firefighters

### **SECTION 7: Handling and storage**

#### 7.1 Precautions for safe handling

Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Do not ingest. The product has been assessed following the conventional method and is classified for toxicological hazards accordingly.
