SECTION 4: First aid measures**4.1 Description of first aid measures**

5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture :	Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. 5.3 Advice for firefighters

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Cool closed containers exposed to fire with water. Do not release runoff from fire to drains or watercourses. 8.2 Exposure controls

Appropriate engineering controls

All engineering control measures used to control exposure to hazardous substances must be selected, maintained, examined and tested to meet the requirements of the Control Of Substances Hazardous to Health regulations (COSHH). Similarly all personal protective equipment, including respiratory protective equipment, must be selected, issued and maintained to meet the requirements of COSHH.

These requirements include the provision of any necessary information, instruction and training with regard to their use. Special precautions should be taken during surface preparation of pre-1960's paint surfaces over wood and metal as they may contain harmful lead.

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. SECTION 11: Toxicological information**11.1 Information on toxicological effects**

The product has been assessed following the conventional method and is classified for toxicological hazards accordingly. This takes into account, where known, delayed and immediate effects and also chronic effects of components from short term and long term exposure by oral, inhalation and dermal routes of exposure and eye contact.

Exposure to component solvent vapour concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system.
